- 3) Winner must accept delivery of the vehicle within 90 days from when the Viper is released from the Chrysler Plant. All delivery charges are the responsibility of the winner. The vehicle is U.S. DOT specification and the winner must take delivery from a Dodge dealer. Winner will be contacted by telephone and receive certified mail notification.
- 4) All applicable taxes, license and fees are the responsibility of the winner based on the retail value of the prize. Federal law requires the deposit of 28% of such value to be applied toward the winner's tax liability before the prize can be released.
