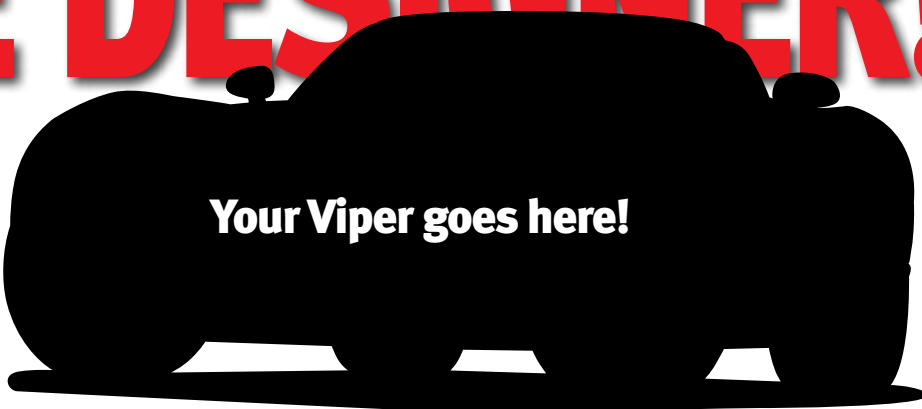


BE THE DESIGNER!

WIN A 2009 VIPER

It used to be so easy. The Viper Club of America would select a Viper off the production line, add some performance modifications and a unique paint job and then all a VCA member had to do was purchase a raffle ticket, sit back—and pray.

The next Viper raffle adds a twist to this process and it's going to require a little more work on the winner's part. As in the past, the prize is a brand new Dodge Viper—this time, a 2009 model. However, instead of taking what the VCA offers, it will be up to the winner to decide exactly what this car will look like. And with the selection of body



styles, colors, stripes and wheels that is now available, this is not going to be an easy task. Currently there are eight colors (with maybe another one or two on the way for 2009), five different stripe colors, three different wheels, four optional two-toned interiors—the list goes on and on. Like we said, it's going to be a difficult choice.

Of course, before you can have this “problem,” you have to get your raffle tickets. With the combinations of options now available on the Viper, there's no doubt that the raffle tickets for this car are going to go extremely fast. Be sure to get yours today. It's going to be a tough job—but someone has to do it. It might as well be you.

Note: Ticket orders CANNOT be taken over the phone.

The deadline for requesting tickets by fax or mail is August 12, 2008. Tickets will be available on-site VOI.10 August 26–28. The drawing will be held August 30, 2008. Simply fill out this ticket order form and return it to Viper Headquarters by fax or mail.

RULES –4/08/08

- 1) All 2008 VCA members as of August 12, 2008, may participate in the raffle.
- 2) Tickets are \$125 each, or three for \$300. For Venom members tickets are discounted 5 tickets for \$500. Final deadline for mail or faxed orders is August 12, 2008. **Any remaining tickets will be made available for purchase on-site August 26–28 at VOI.10, cash or credit card only will be accepted for the purchase of those tickets.** The drawing is August 30, 2008. Winner need not be present to win.
- 3) Vehicle must be ordered through a Dodge dealer by September 29, 2008. Vehicle must be ordered to 2009 factory configurations and options available to dealership on the drawing date of August 30, 2008.
- 4) Winner must accept delivery of the vehicle within 90 days from when the Viper is released from the Chrysler Plant. All delivery charges are the responsibility of the winner. The vehicle is U.S. DOT specification and the winner must take delivery from a Dodge dealer. Winner will be contacted by telephone and receive certified mail notification.
- 5) All applicable taxes, license and fees are the responsibility of the winner based on the retail value of the prize. Federal law requires the deposit of 28% of such value to be applied toward the winner's tax liability before the prize can be released.
- 6) Odds of winning the vehicle will be based on the total number of tickets sold, but no greater than 2,009 to 1.
- 7) Tickets will be issued only to the name(s) listed on the ticket form itself. The prize will be awarded on the same basis. Winning ticket cannot be assigned, transferred or sold.
- 8) 2008 National VCA officers, J.R. Thompson Company employees, and President of Motor City Viper Owners, Inc., may not participate in the raffle.
- 9) Requests for tickets must be sent on this official form and mailed to Viper Club of America-RAFFLE, 26970 Haggerty Road, Farmington Hills, MI 48331, or fax the order to (248) 553-2138. Upon receipt of the ticket order form, your ticket(s) will be forwarded to you via first-class mail.
- 10) Results of the drawing will be certified at MotorCity Casino Hotel at 2901 Grand River Avenue Detroit, MI 48201. Drawing will be held at this inside location on August 30, 2008, between 7p.m. and 9 p.m. EDT, and will be held regardless of weather.
- 11) The winner will be selected from the container in which the purchased ticket stubs for each entry shall be mixed and drawn on a random basis. Each ticket shall have equal chance to win.
- 12) This offer is void where prohibited by law.
- 13) Ticket requests received by fax or mail after August 12, 2008, will be returned.
- 14) Ticket requests are subject to acceptance by VCA.
- 15) Results will be posted on the VCA Web site, www.viperclub.org.
- 16) Raffle is sponsored by the Motor City Regional Viper Club of America.
- 17) You must be at least 18 years old to purchase a ticket.
- 18) A maximum of 2,009 tickets will sold and only on a first request basis. All ticket requests in excess of the limit will be returned.
- 19) If less than \$120,000 of tickets are sold, a 50/50 Raffle will be held and a cash prize of half of the gross ticket sales will be awarded, instead of the 2009 Dodge Viper.
