

The 1st Customer 600 HP '08 Viper Can Be Yours!

The new 2008 Dodge Viper SRT10s will start rolling down the assembly line very soon. However, the first 2008 Viper built for sale to the public has been set aside for a very special purpose—the Viper Club of America raffle. This means you can't buy the first customer 2008 Viper, but you can win it!

And even though being the first one off the line would be enough to make it special, the VCA is going even further to make this car unique. The car will have special VCA identification/badging to commemorate it as "one of one". The Viper will come in the new Venom Red color and will be adorned with Champagne-colored stripes. These stripes are not available on any other production Viper, so this car will be truly one of a kind. In addition, this raffle car will sport the new optional Razor wheels.

The VCA is also adding a number of enhancements to this Viper, including:

- Mopar Adjustable Coil-Over Racing Suspension Kit – These shock absorbers have been tuned by Mopar and SRT race engineers to provide the maximum

handling performance without sacrificing reasonable road manners. The 2-way adjustable dampers include piggy back reservoirs with adjustments for bounce and rebound. The threaded shock tube also allows ride height adjustments of +/- 25mm. (Delivered upon availability of parts.)

- Custom Prefix Stripes – Champagne color

These race-inspired components will take this Viper's street and track performance to a whole new level.

With the combination of being the first built, having an exclusive color scheme and with the Mopar Performance parts, there's no doubt that the raffle tickets for this Viper are going to go extremely fast. Be sure to get yours today.

- 1) All 2007 VCA members as of October 22, may participate in the raffle.
- 2) Tickets are \$125 each, or three for \$300. Final deadline for purchasing tickets is October 22, 2007. The drawing will be held October 31, 2007.
- 3) Winner must accept delivery of the vehicle within 90 days from when the Viper is released from the Conner Avenue Assembly Plant. The vehicle is U.S. DOT specification and the winner must take delivery from a Dodge dealer. Winner will be contacted by telephone and receive certified mail notification.
- 4) All applicable taxes, license and fees are the responsibility of the winner based on the retail value of the prize. Federal law requires the deposit of 28% of such value to be applied toward the winner's tax liability before the prize can be released. **Approximate retail value: \$120,000**

- 5) Odds of winning the vehicle will be based on the total number of tickets sold, but no greater than 2008 to 1.
- 6) Tickets will be issued only to the name(s) listed on the ticket form itself. The prize will be awarded on the same basis. Winning ticket cannot be assigned, transferred or sold.
