Ticket orders need to be placed in consecutive order to receive the discount for Venom members. Final deadline for receipt of mail or faxed orders is October 16, 2009. The drawing is October 30, 2009. Winner need not be present to win.
- 3) Winner must take delivery of the vehicle by November 30, 2009. All delivery charges are the responsibility of the winner. The vehicle is U.S. DOT Specification. Winner will be contacted by telephone and received certified mail notification.
- 4) All applicable taxes, license and fees are the responsibility of the winner based on the retail value of the prize. Federal law requires the deposit of 28% of such value to be applied toward the winner's tax liability before the prize can be released.
